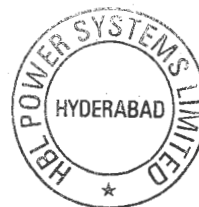
In the aforesaid Court Convened Meetings of secured and unsecured creditors, both the secured and unsecured creditors have approved the scheme unanimously.

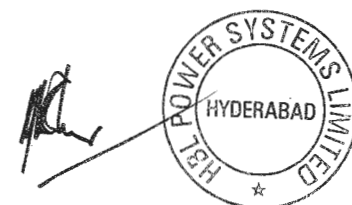
